


A grassroots movement to change the I/DD landscape in North Carolina by improving the lives of those with I/DD and their families through a collective impact model



# Nov 2023 I/DD Policy Think Tank Goals

- Strengthen the advocacy platform for the I/DD service and support system
- Create new partnerships
- Develop strategies for working together
- Recognize and value the range of perspectives





# Fall I/DD Policy Think Tank, Nov 3, 2023

- 78 total Participants: 26 in person; 52 online
- 48 Non-MTN; 30 MTN advisory members = 62% New; 38% MTN
- 34 with Lived Experience (13 Self-Advocates; 21 Parent

Advocates); 44 Other; 47 Organizations represented

- Across systems, disabilities, ages, level of challenge, region
- Individuals from State Agencies (DHHS, Medicaid, Juvenile Justice), LME-MCOs, Providers, 501c3 nonprofits, advocacy organizations, other collective impact initiatives, universities, consultancies, disability advocates with I/DD lived experience

# I/DD Policy Think Tank, November 3, 2023

## **#2 INNOVATIONS WAIVER GOAL**

Encourage transparency about where and when the 350 new Innovations Waiver slots will be allocated.

## **#3 LME-MCO CONNECTIONS GOAL**

## **#4 DSP MESSAGING GOAL**

Educate legislators and other target audiences on the need for a pathway for increasing DSPs (Direct Support Professionals) and living wages, within the Direct Care Workforce framework, using simple, more accessible messaging.
